- Once the completed Scholarship Application Form, Letter of Request, and tax information have been received, the application will be taken under consideration. An application missing any of these documents will be considered incomplete and cannot be considered for a scholarship.

Scholarships are limited; a scholarship application does not guarantee a spot in a program.

All scholarship applications are taken under consideration for either a full or partial scholarship, depending on the financial need of the participant.
